We are delighted to announce that the membership of the National Schools Programme Strategic Advisory Group (SAG) has been confirmed. The establishment of the Strategic Advisory Group is an outcome of Recommendation 5 of the [2024 NSP Review](#), and its role will be to oversee and monitor the implementation of the fifteen NSP Review recommendations.

The Strategic Advisory Group will be co-chaired by Mhairi Harrington, OBE, alongside Erica Russell-Hensens, Deputy Director of Student Interests, Access & Quality at SFC. Mhairi has worked for over 40 years in Education and has invaluable expertise spanning from Primary Education to Adult Learning. She currently sits on the [SFC Board](#), and is involved in several of SFC's Board Committees:
