Introduction

- 1. This Technical Guidance provides the definitions for each of the measures pertaining to Scottish colleges in the Outcomes Framework & Assurance Model (OFAM) measures.
- 2. The full list of OFAM measures for colleges may evolve over time as new requirements and focus areas arise. SFC will, as a matter of course, continue to monitor all performance measures.
- 3. Definitions for the data and measures are provided at a high level. Outcome Managers will work with institutions to interpret and apply the measures by taking a data and insight centred approach that reflects the context and priorities of the institution.

General Notes

Definitions

- 4. Where a measure in this document has been sourced from the SFC's Further Education Statistics (FES) return, the fields and descriptions have been taken from the relevant FES guidance notes. <u>Full details of the FES field list and definitions</u> are available on the SFC website.
- 5. Where enrolment totals are calculated, only those which met the SFC funding date threshold are included. See SFC credit guidance for more details. This applies to all measures counting enrolments, entrants, qualifiers and outcomes.

UHI/SRUC HE Provision

6. HE provision data for UHI partner colleges and SRUC is returned via the HESA student record. For this reason, the University technical guidance provides the definitions for the measures pertaining to HE provision at these institutions

Student Enrolment Outcomes

7. To measure the outcomes and performance of Scotland's colleges, some OFAM measures calculate the proportion of enrolled students successfully achieving a recognised qualification for a given cohort. Such measures are based on the FES2 student record outcome and adhere to the methodology used in SFC's Student Outcomes publication. Guidance for the measures used in the publication can be found on the SFC website.

Scottish Index of Multiple Deprivation

- 8. The <u>Scottish Index of Multiple Deprivation (SIMD)</u> is provided by the Scottish Government (SG). <u>Postcode files linking postcodes to SIMD rank</u> are available on the National Records of Scotland (NRS) website via NRS Postcode Extracts in the Geography web page. Using the student postcode (FES 2 field: permanent home location (domicile of student)) a student is matched to a datazone and then to a SIMD rank. The ranks are divided into quintiles and deciles.
- 9. In this guidance MD20 = Quintile 1 and MD40 = Quintile 1 + Quintile 2.

Timing

10. This guidance will apply in Academic Year (AY) 2025-26. However, under OFAM data is monitored retrospectively based on the most recently available data returns. In the case of AY2025-26, this will be data relating to AY2023-24 or AY2024-25, when it is available.

Additional Guidance

11. This Technical Guidance should be used in conjunction with the general OFAM Guidance. The

general OFAM Guidance provides more detail on OFAM, setting out how SFC will monitor and engage with each college, college region and university, and is published alongside this Technical Guidance.
