DEVELOPMENT OF SIMULATED PLACEMENTS WITHIN HIGHER EDUCATION INSTITUTE SETTINGS

I am writing to let you know that the Scottish Government will transfer extra funding to the Scottish Funding Council (SFC) so that you can fund higher education institutes (HEIs) to employ additional staff to develop simulated clinical placements within HEI settings. The Scottish Government is committed to ensuring there is adequate provision of student placements for Nursing, Midwifery and Allied Health Professional (NMAHP) students which have been under pressure due to Covid-19.

The funding will total £3,830,557 over 2 financial years 2021/22 and 2022/23. This will enable HEIs to compensate for missing placement experiences for students on NMAHP programmes. Additional placement capacity will be required over the remainder of the next 2 academic years, AY 2020/21 and 2021/22. This equates to funding for 1.5 years fixed term contract. Scottish Government Health and Social Care Directorates will transfer initial funds to the SFC as part of Budget (Scotland) 2021 Amendment Regulations 2021 - Autumn Budget Revision.

We would like the SFC to provide the funding to HEIs and monitor spend working with them to ensure that funds are used only for the purposes intended. The funding is intended to be spent primarily on staffing to support simulated and alternate placement provision. The SFC should monitor progress on the spend towards simulated placement development and should recover funds under-spent by HEIs at the end of each financial year.

Annex B

Nursing and Midwifery breakdown of funding

The same formula as AHP across the 11 providers of Nursing and Midwifery education has been applied (OU has a different funding model), taking into account that demand for additional HEI placement hours will be less than that for AHP students.

The calculation is based on:

- 2 FTE, fixed term contract, per HEI with over 200 student intake per year (AY 2020/21);
- 1 FTE for HEIs with 100 -200 student intake per year; and
- pro rata below 100 student intake.
