National policy for Further Education bursaries AY 2022-23

Introduction

- This policy document stipulates the conditions of use of Further Education (FE) bursary funds allocated to colleges by the Scottish Funding Council (SFC) and sets out the rates for calculation for Academic Year (AY) 2022-23. This policy continues to support the strategic priorities and outcomes of SFC and the Scottish Government.
- 2. Student support funds are cash-limited. Students who are eligible for support from this funding are not automatically entitled to this support.

Updates for AY 2022-23

- 3. The updates to the paragraphs and relevant sections of the guidance are set out in the annex to this announcement. The main changes are:
 - Increase in bursary maintenance rate

The annual bursary maintenance rate has been increased by 4.1% to a maximum of £4,859.00. Split over 43 weeks, this provides a new maximum weekly award of £113.00.

• Informal Care-Experienced

As part of the ongoing work to align with Student Award Agency Scotland (SAAS) policies and procedures where possible, we are widening access to the Care-Experienced Bursary to students in informal care arrangements where this can be confirmed by Social Work departments.

• Duration of support

We have introduced some additional flexibilities on the duration of student support:

- Longer duration: Students should be supported for the duration of their FE studies if they are continually progressing between levels (within SCQF levels 1 to 6). Consistent with our previous policy, students whose learning follows a non-standard pattern (e.g. those with learning disabilities) will not be required to be progressing between levels.
- Plus 1: Colleges will be able to support students for one additional year at the same SCQF level, if required. In line with the SAAS policy, students can use their 'plus one' year for a change of course or repeat year for academic, health or compassionate reasons.
- **Returners:** Colleges will also have the discretion to support returning students. This includes students who already hold a higher level

qualification and want to re-train in a different subject starting from a lower level. It also includes those who need to upskill in their existing subject.

 COVID-19 interruption: Students whose learning has been interrupted by COVID-19 will not have the period of disruption count towards their overall duration of support.

COVID-19

- 4. Colleges are continuing to work through unprecedented times as we recover from COVID-19. In AY 2022-23 SFC will continue to work with the sector to support students and staff in this context.
- 5. SFC is publishing its National Policy for Further Education Bursaries to provide advice for college student support practitioners. We are aware of, and fully appreciate, the impact which those who work on student support have encountered during the pandemic. We also recognise the impact the pandemic continues to have on students' finances, a situation which is now compounded by cost of living pressures.
- 6. These documents aim to provide a standard foundation upon which student support funding award assessments and decisions can be made by college staff. Where there is a need to provide additional or exceptional guidance in relation to COVID-19 aspects, we will continue to circulate this information directly to our established student support sector contacts, and publish it on the <u>COVID-19 page</u> of SFC's website.
